GUESTS PER NIGHT. THE AVERAGE LENGTH OF STAY WAS 173 DAYS AND THE
AVERAGE FAMILY SIZE WAS 3.37. PSP SERVED (UNDUPLICATED) 342 INDIVIDUAL
FAMILIES TOTALING 544 SHELTER STAYS. IN 2024, PSP WELCOMED BACK MORE
VOLUNTEERS AND HAD 995 VOLUNTEERS WHO DONATED 8,435 HOURS OF TIME. PSP

FINANCIAL ASSISTANCE AVAILABLE TO PARTICIPATING FAMILIES AND EXPANDED
THE PROGRAM TO SERVE MORE FAMILIES. THIS PROGRAM AIMS TO PREVENT THE

THIS AGREEMENT AND PLAN OF MERGER is made effective as of December 11, 2024, between People Serving People Charities, Inc., a Minnesota nonprofit corporation ("PSPC") and People Serving People, Inc., a Minnesota nonprofit corporation ("PSPI"). PSPC and PSPI are collectively referred to as "Constituent Corporations."

WHEREAS, the Boards of Directors of the Constituent Corporations deem it advisable and in the best interest of the Constituent Corporations that PSPC be merged with and into PSPI (the "Merger").

NOW, THEREFORE, the Constituent Corporations hereby agree as follows:

1. The Merger shall be in accordance with Sections 317A.601 et seq. of the Minnesota Nonprofit Corporation Act.
2. The Effective Date of the Merger shall be December 31, 2024 at 11:59 p.m. (Minneapolis time).
3. Upon the Effective Date, PSPC shall be merged with and into PSPI and PSPI shall be the Surviving Corporation.
4. From and after the Effective Date (unless and until further amended in accordance with the Minnesota Nonprofit Corporation Act), the Articles of Incorporation of PSPI in effect immediately prior to the Effective Date shall be the Articles of Incorporation of the Surviving Corporation.

The directors of both Constituent Corporations as of the Effective Date shall be the directors of the Surviving Corporation.
